**Directions to SNEBC Walking Field Trial at Arcadia Wildlife Management Area**

From I-395

Take exit 85 onto Route 138 East. Follow 138 East until it intersects with Route 165 outside of Voluntown, CT. Follow Route 165 East into R.I.. Continue past Beach Pond to white Church on left, turn left at Church onto Frosty Hollow Road. Proceed on Frosty Hollow Road to intersection, turn left to Field Trial Grounds.

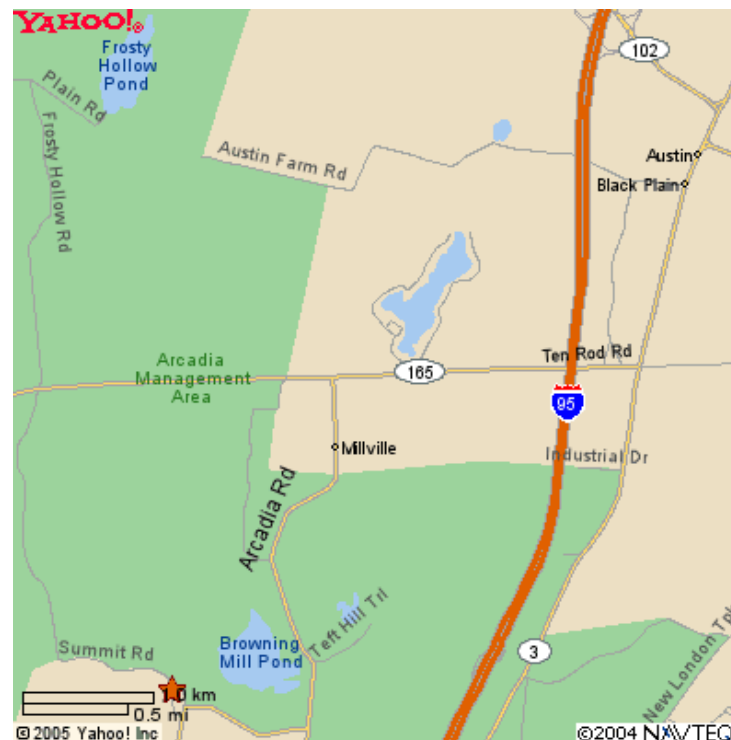


From Boston, MA / Providence, RI

I-95 South to exit 5A (102 South). Follow this about a mile or so until you reach Route 3. Take a right and go about 1.5 miles until you see a blinking yellow light. Take a right here onto 165 West (Ten Rod Road) and proceed approximately 2.8 miles. At the bottom of a hill, at a white Church, turn right onto Frosty Hollow Road. Proceed on Frosty Hollow Road to intersection, turn left to Field Trial Grounds.

From New London, CT

I-95 North to exit 4 (Route 3). Follow 3 North until the blinking yellow light. Go left on 165 West and follow the previous directions from there.
