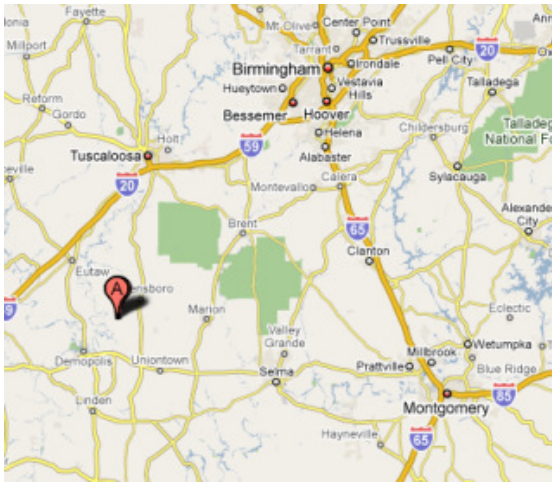

Seven miles south of Greensboro on Highway 69, turn right on County Rd 16. Go 1/1 miles and turn right on County Road 73. Follow signs to Cattle Ranch.

**From Montgomery**

From Highway 80, turn North on Highway 69 and follow approximately eight miles to County Road 16 and turn left. Go 1.1 miles and turn right on County Road 73. Follow signs to Cattle Ranch.
