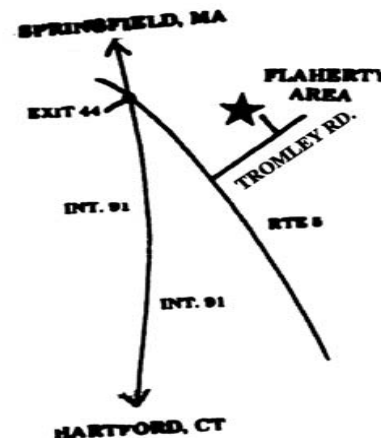
## CENTRAL NEW ENGLAND BRITTANY CLUB
