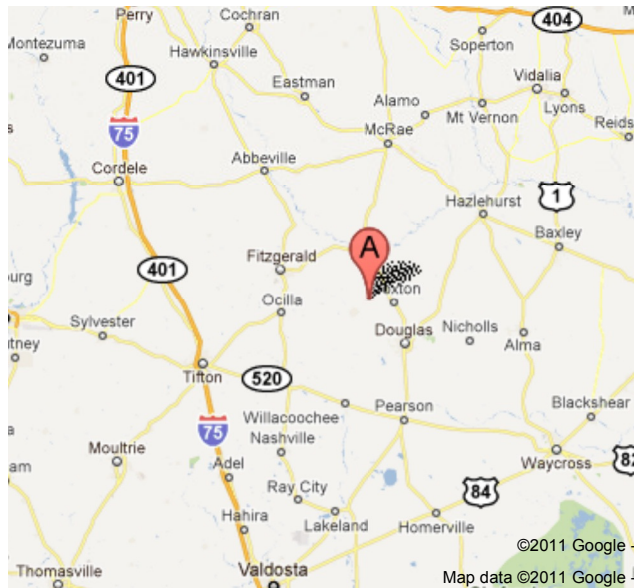

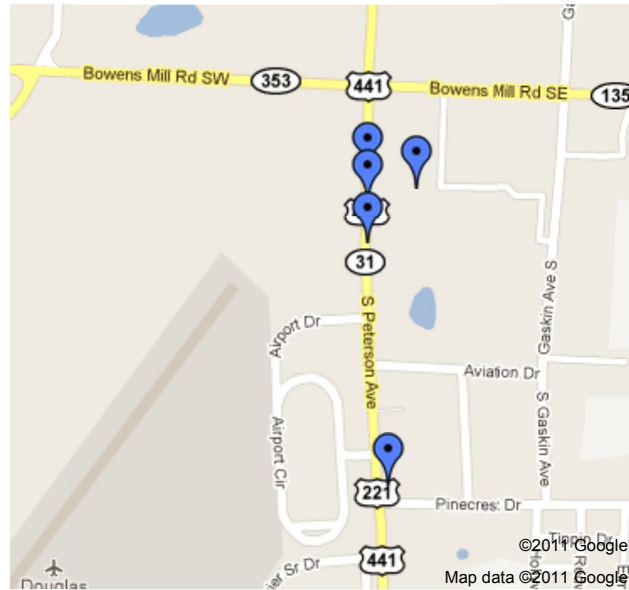

A Horse Wrangler will be available for horse rentals.

Entry feeds do NOT include fees for handler or gallery horses.

All riders of rental horses must sign a Liability Release that will be available on the grounds. The Georgia Brittany Club assumes no liability for any activity associated with horses at the trial.

**The wrangler is Lee Allison. 706.361.1926. He is planning to bring about six horses to the trial. Rental rates are \$85 / day or \$25 / brace.**
