This trial is licensed by the **AKC** and recognized by the **American Field**. Your dogs do not have to be registered in the Field Dog Stud Book to compete, but only dogs with FDSB registrations will be recognized as qualifying at this trial to run in American Field championships.

Directions: Interstate 70 west in Maryland exit 18N Clear Spring. Follow route 68 to town of Clear Spring. McDonald's on right. Go straight through light, at top of hill bear right to stop sign, continue to right onto Broadfording Rd.

Go about 1 mile and turn left onto Blairs Valley Rd. watch for Ski White Tail sign. Continue on Blairs Valley Rd. about 2 miles, you will see lake on left and fish and game buildings. Field Trial grounds are on left about 1/2 mile past last fish and game building. Watch for dirt road with sign on utility pole. If you pass White Tail you have gone too far.
