ATTENTION EXHIBITORS

The show site will be available to exhibitors Friday, July 7, 2006 at 10:00 a.m. Dogs must be removed from the show site immediately following Best in Show judging on Sunday.

A Recording Fee of 50 cents and Event Service Fee of \$1.50 will be required for each dog entered at any Licensed or Member Club Show or Obedience Trial. This Recording Fee is to be collected by the show giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Recording Fee and Event Service Fee are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2)

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs must be ready for judging. The club is not responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show- None will be mailed.

RETURNED CHECKS do not constitute a valid entry fee. The club will add a \$12 collection fee to the amount of each returned check. Subsequent checks from the same exhibitors may result in their being put on a CASH ONLY basis for future shows.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, public emergency, act of a public enemy, or strikes or any other cause beyond the control of the Club or Superintendent.

The sponsoring club assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures. One Check is sufficient for all entries enclosed.
