Courses, Birds, and Other Comments

All stakes single course without bird field.
 Native and/or liberated quail in all stakes, except Open Puppy
 All adult stakes 30 minutes, derby stake 20 minutes, and puppy stake 15 minutes.
 Blank cartridges will be fired in puppy stakes if bird contact is made.
 NO OPEN BARREL GUNS PERMITTED and only up to .38 caliber.
 Horseback handling is permitted in all stakes.
 Use of AKC approved tracking collars/GPS devices is permitted.
 Horses will not be provided by Mid-Florida Brittany Club, Inc.
 The Field Trial Committee reserves the right to use additional course(s) and/or change the order of the stakes offered to be able to finish the event in the time allowed.
Mid-Florida Brittany Club accepts and encourages foot handling in all stakes.

Prizes

AKC standard rosettes to all placed dogs.
 The Mid-Florida Brittany Club will retain 50% of all entry fees collected in the Open Limited Gun Dog Stake and the remaining 50% will be divided as follows:

General Information

The Field Trial will be considered over when the last person leaves the grounds on Sunday, 11 October 2009.

No field training is allowed while on the field trial grounds. Dogs may be exercised off lead in the field immediately inside the Masaryktown Field Trial Grounds. The field is next to US Hwy. 41. Take care that your dog(s) does not run onto the highway. The landlord, property owners and the Mid-Florida Brittany Club assume no responsibility for any loss, damage or injury sustained by persons, dogs or personal property while on the Masaryktown Field Trial Grounds.

If your dogs, horses, family members or guests dig holes, you are expected to re-fill them before you leave. Keep motor vehicles on the obvious roadways. Do not drive across fields. Excessive drinking will not be tolerated. Please, do not drink and drive!

Refund of each entry fee(s), less \$15.00 for expenses, will be made if it is impossible to open or complete the event due to riots, civil disturbances, acts of God or nature that are beyond the control of the Mid-Florida Brittany Club, Inc.

Directions, Camping, Lodging and Food

From I-75 proceed West on Hwy 52 to the intersection of Hwy 41 (approximately 11 miles). Turn right (North) on Hwy 41 and go approximately 6 miles and you will see field trial signs on the left. Go down the embankment, open the stock gate and follow road to Field Trial Grounds. Please be sure to close the stock gate behind you.

Camping is allowed on the Masaryktown Field Trial Grounds. No electric hookups are available. Water and an outdoor, hot water shower are available on the grounds. If you cook out, keep your fire under control. When you leave be sure your fire is thoroughly out and fire pit is completely covered. Safety comes first! Please respect your fellow campers and keep noise to a minimum at night. Please pick up around your campsites. Do not put trash on the ground, and use the trash containers

North of the Masaryktown Field Trial Grounds, ~1/4 mile on US 41 is Big Oaks R. V. Campgrounds (352.799-5533) with full hookups for campers. Hot indoor showers are available there.
