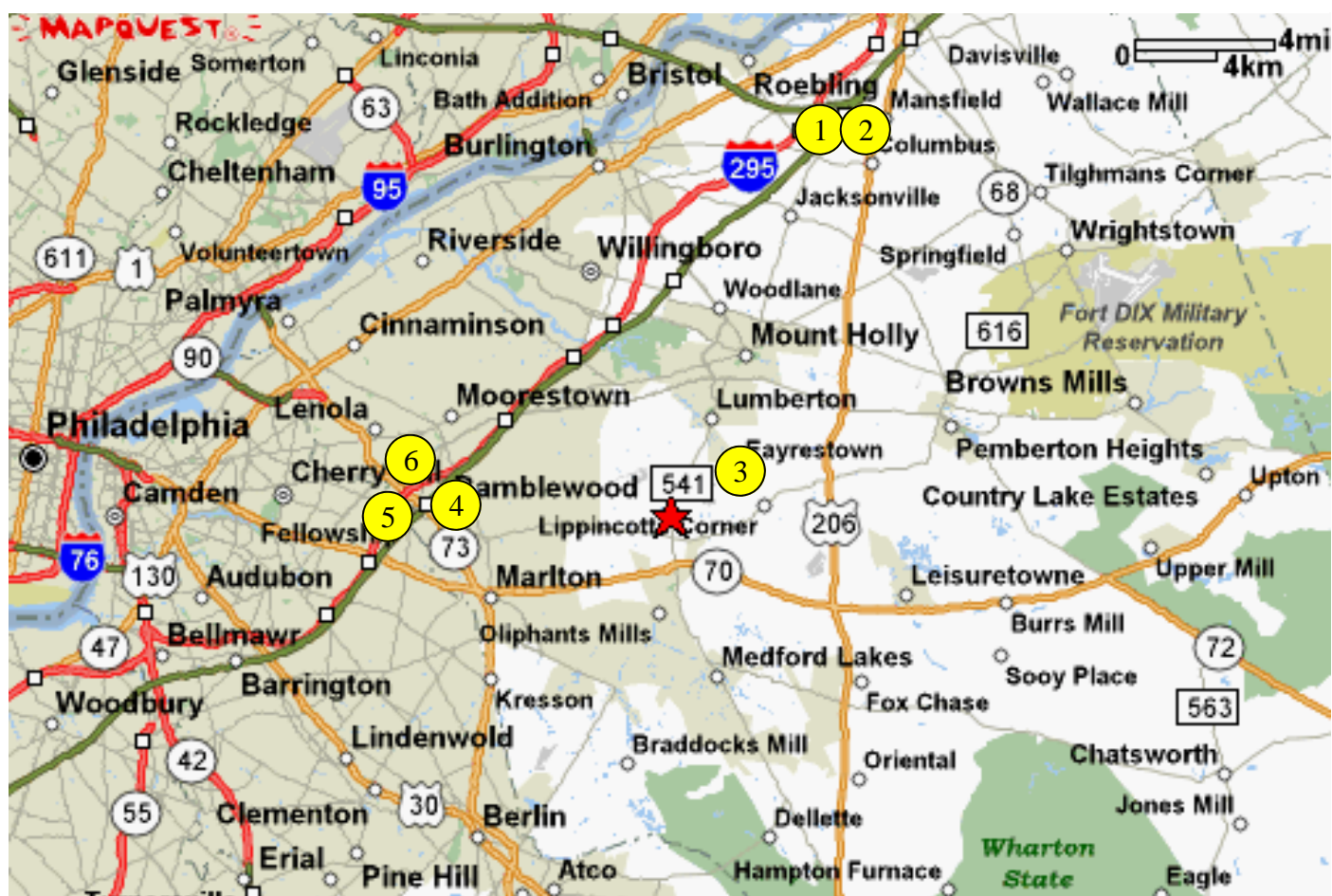

DIRECTIONS

Watch for the English Setter Club driveway on the right immediately after the soccer field. From the West, take the Pennsylvania Turnpike east to the NJ Turnpike south, Exit 5, then see above.
