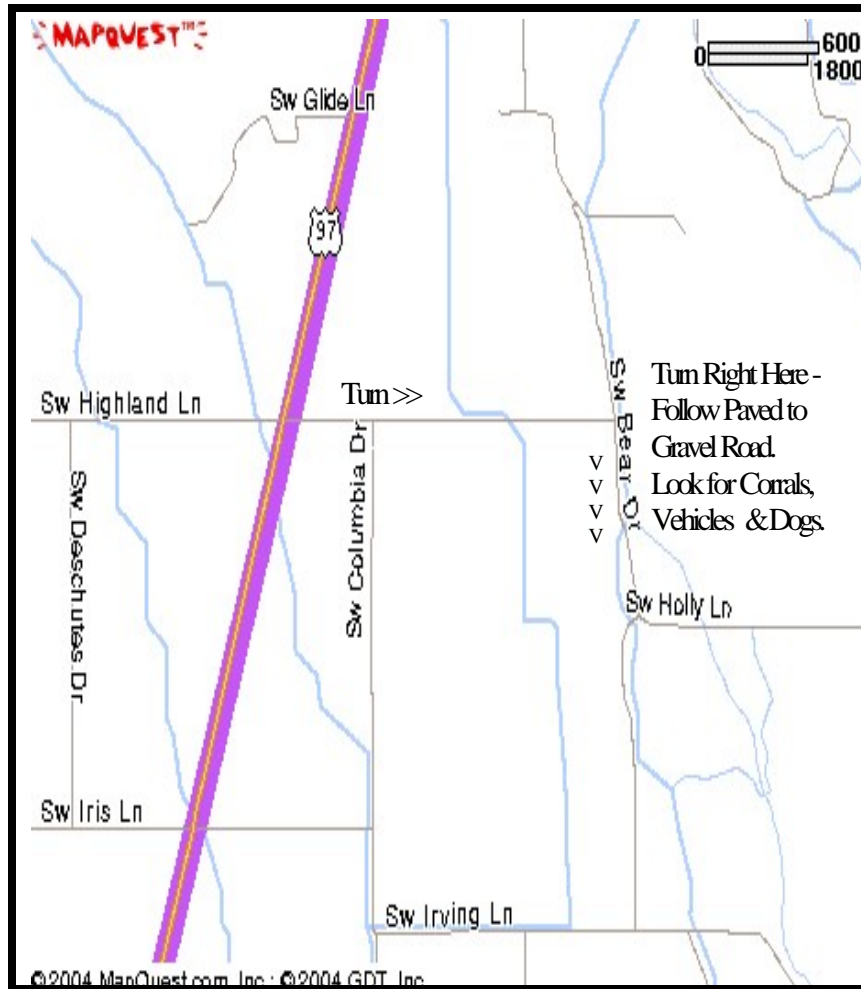

The Hunter's Gun Dog Stake is for:

- New handlers and pointing dog owners
- Junior Handlers
- Owner's with dogs that are too old for Puppy or Derby, but would like to experience the field trial environment
- Dogs and owners of any age may compete (registered or un-registered)

Entrants will walk a 20 minute course with a bird field where each dog will have the opportunity to work at least one bird. Judges will guide and advise handlers and provide feedback/answer questions following each brace. Firing a blank pistol with each bird contact is encouraged but not required. Loaner field trial equipment (blank pistol, colored dog collar, tracking collar, etc..) will be available.

Entries: Use attached form and mail with your check to the field trial secretary.

Prizes: Awards will be given for varying aspects of performance

Note: This is a nonconforming event and is designed to provide the experience of entering a field trial. The event does not provide championship points and is not subject to the rules of the standard conforming field trial stakes.
