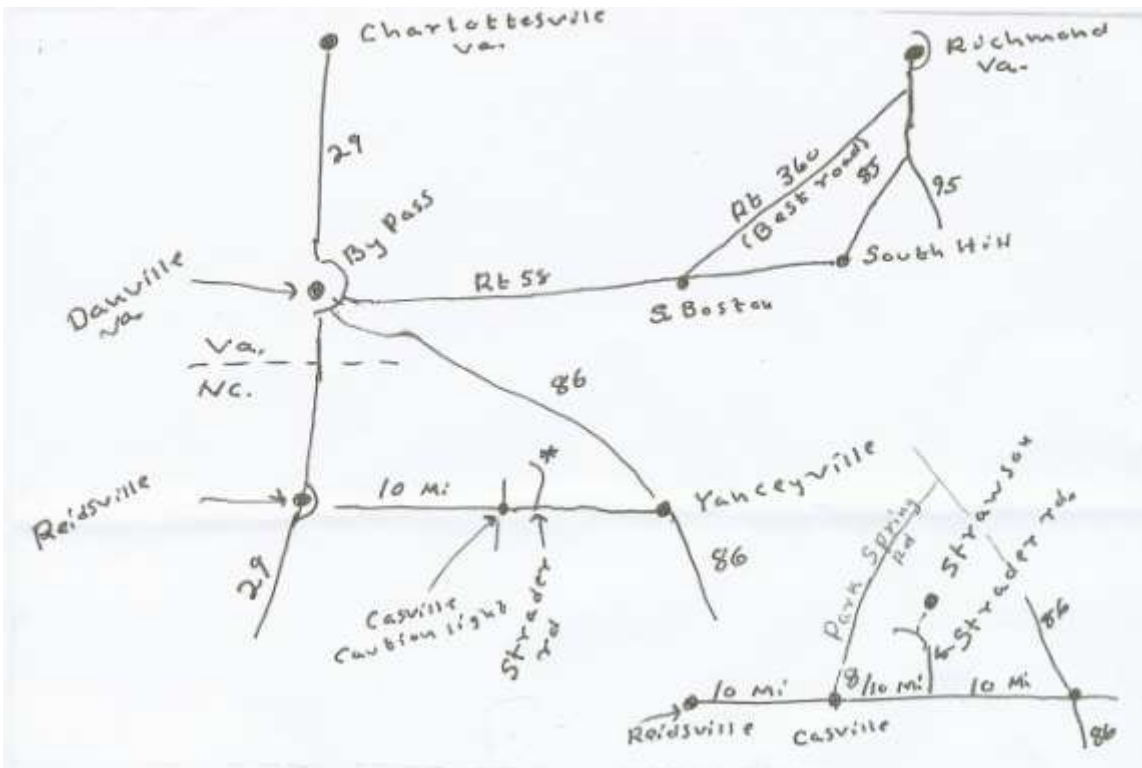
**DIRECTIONS**
