COURSES AND BIRDS

All stakes are single course without birdfield.

OPEN PUPPY

Single course – no birds released.
A blank cartridge will not be fired in the puppy stake.

Released Bobwhite Quail and Native Quail in all stakes except Open Puppy.
A blank cartridge will be fired in all stakes except the Open Puppy stake.
Horseback handling will be permitted in all stakes.
No handler horses will be provided.
Shotguns are not permitted on the grounds.

Standard AKC Rosettes to all placed dogs in all stakes.
Prizes awarded for first & second in the Championship stake.
