ALL ADULT AND JUVENILE STAKES will be run on the Hoffman Field Trial Grounds.

CORRALS, STALLS, KENNELS are available on the grounds. *Please clean before leaving.* No dog training is allowed on the field trial grounds, but adjacent areas for roading and running dogs is available on specified days. A NC Permit must be obtained.

CAMPING: Camping is permitted on the grounds Thursday, Friday, Saturday & Sunday nights. **NO ELECTRICAL HOOKUPS WILL BE AVAILABLE OR ALLOWED.**

DIRECTIONS: From Southern Pines: Take US 1 South until it narrows to 1 lane in either direction (construction). From that point, go 4.7 miles. Turn right (BP Gas Station on near right side) on Caddel Rd. Go short distance (about .1) and turn right when the road splits with island. Continue approximately 3 miles to entrance to field trial area on left. Follow sand road approximately 3 miles to clubhouse. From 220 South, take exit 24, turn left at end of ramp, go approx. 2/10 mi. and turn left on Windblow Rd., cross Rt. 73 and follow to end. Turn right and look for entrance to trial grounds on right.
