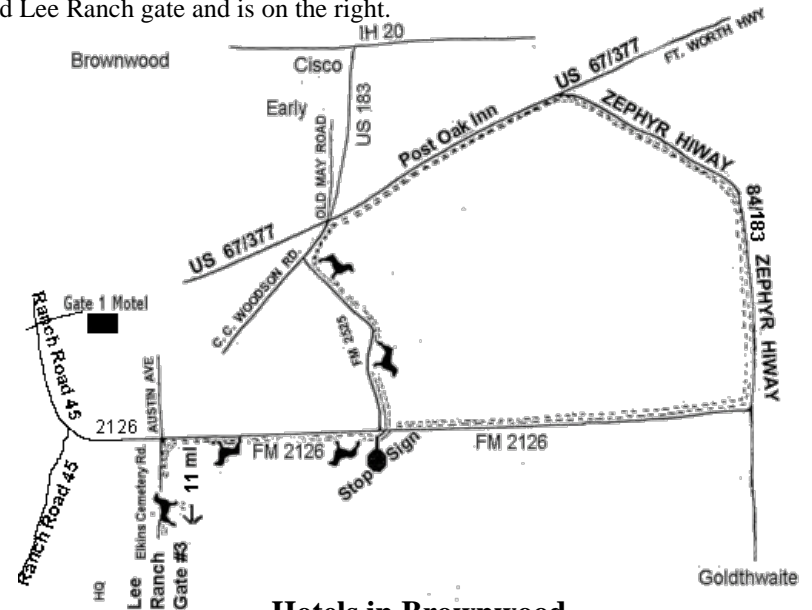

Directions to Trial Grounds

From Brownwood Hwy 377 at Mr. Gatti's, south on CC Woodson Rd 0.7 miles to FM2525. Left on FM2525 and go about 3 miles to FM2126. Right on FM 2126 for about 5.5 miles. Left onto Elkins Cemetery Rd (CR267) for about 11 miles. Lee Ranch Gate #3 will be on the right and the second of 2 gates to the Lee Ranch.

From Gate 1 Motel in south Brownwood, south on Hwy 377, left at Ranch Road 45. Turn left onto FM2126 at the fork, right onto Elkins Cemetery Rd (CR 267). Go about 11 miles to Gate #3 which is the second Lee Ranch gate and is on the right.

Alternate route to bypass Brownwood, on Hwy 377, take the Zephyr Highway in Early south to FM2126. Stay on FM2126. From the stop sign on 2126 go another 5.5 miles to Elkins Cemetery Rd. Left on Elkins Cemetery Rd about 11 miles to Gate #3 which is the second Lee Ranch gate and is on the right.
