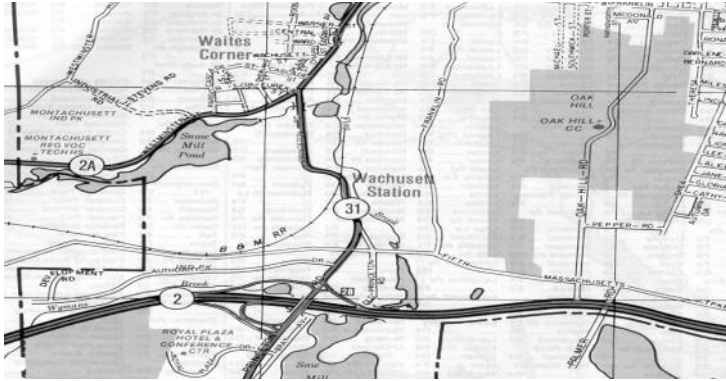

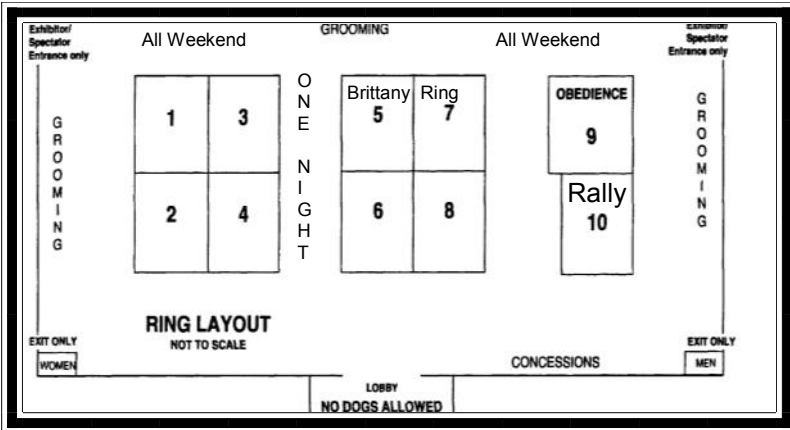

NOVICE JUNIOR CLASS: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN SENIOR CLASS: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

Best Junior Handler. The Junior Handler placed first in each of the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.

NON-REGULAR CLASSES

Field Trial Dogs & Field Trial Bitches - A class for dogs and bitches which have placed in a licensed AKC Field Trial held by an AKC Member Club or Licensed Field Trial Club **within the past year (August 3, 2010—August 3, 2011)**

Hunting Test Dogs & Hunting Test Bitches - A class for dogs & bitches which have earned an AKC Junior, Senior or Master Hunting Title.

Veteran Dogs & Veteran Bitches - A class for dogs and bitches eight years or older.

NOTE: Chapter 14, Section 8 of the dog rules provides that castrated males *may be entered* in the Veteran Dog Class and spayed females *may be entered* in Veteran bitch class at Independent Specialties only.

NON-REGULAR CLASSES (MULTIPLE DOG ENTRIES)

Stud Dog Class - Will be for Stud Dogs shown with at least two but not more than four of his Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. Owner of Stud Dog need not necessarily be the owner of the Get. Get only to be judged, based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusable under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in Best of Breed Competition, or some other Regular or Non-Regular Class.

Brood Bitch Class - Will be for Brood Bitches and at least two but not more than four of their Produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. Owner of Brood Bitch need not necessarily be owner of the Produce. Produce only to be judged, based on the merits of the Produce. While the merits of the Produce are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification, or to be excused under the Dog Show Rules, AKC policy or the standard for its breed. Get must be entered in Best of Breed Competition, or some other Regular or Non-Regular Class

Brace Class - Two dogs of the same Breed with identical ownership.

NOTE: At the judge's decision the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch; no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed or Variety by virtue of having won his class.

BOB- J.A.M. may be awarded at the judges discretion 1 JAM for every 10 entries.
