Standard AKC Ribbons to all placed dogs. Coffee Mug will be awarded to first placed dogs.

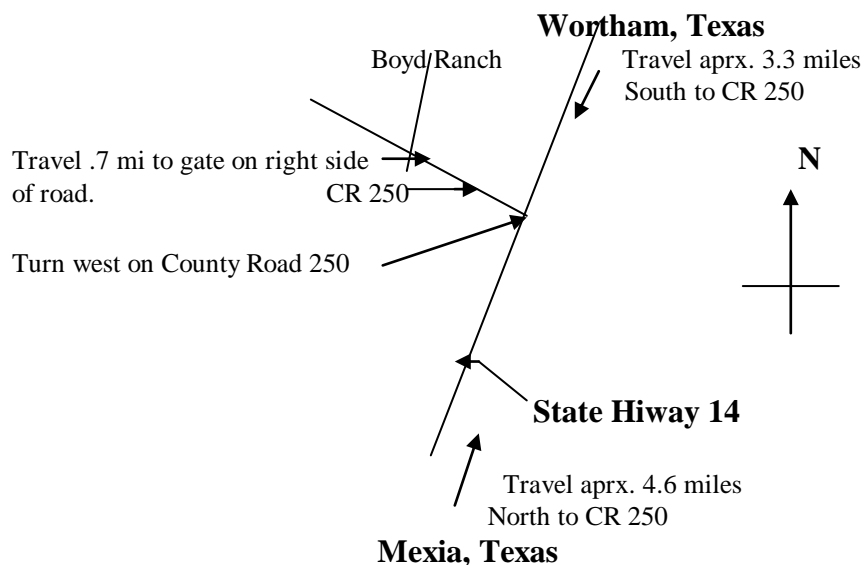
