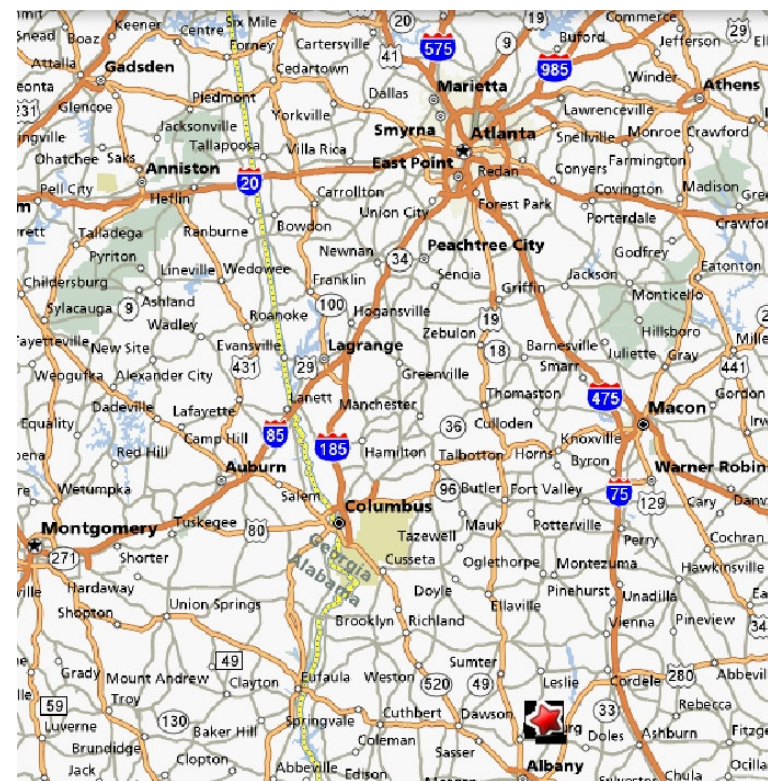

- Follow 195S for 7.3 miles and turn left on Batts Rd (dirt road - look for the Field Trial Sign)
- Go 1.4 miles and bear right at fork in road (watch for Field Trial sign)
- Continue for 2.7 miles until you see the farm/bldg on right
