Welcome to our Fall Field Trial, October 13 & 14, 2007, at Ottawa Field Trial Grounds, Eagle, Wisconsin. Lunch will be available at the grounds on both days. Coffee and donuts will also be on-hand for breakfast.

The entrance to the grounds is located on State Hwy 67, South of County Hwy C and CI. This entrance is reached by traveling on Hwy 67 South from I-94, or North from Eagle, WI.

Anyone planning to camp at the grounds must register with the DNR office at the park entrance. Horses may be kept at the Ottawa Field Trial Grounds. The DNR can provide information on other areas where horses may be kept. A current Coggins Test is required by the State of Wisconsin. The park telephone number is 262-594-6200.

\$2.00 per dog will be donated from your entry fee to the Ottawa Eagle Field Trail Association for grounds improvement.

**SPECIAL NOTICE:** There has been a problem with ongoing complaints about dogs barking early in the morning and disturbing nearby landowners. Realizing that waking up neighbors at a time that many people are typically sleeping is not appropriate, and that in other similar situations legal steps have been pursued to restrict noise producing activities, the Ottawa Eagle Field Trial Association and Department of Natural Resources have decided to implement the following rules for the Ottawa Field Trial Grounds to address noise issues.

The trial/event chairman is responsible for noise enforcement.

Dogs must be kept absolutely quiet before 8:00 am. Dog owners must keep their dogs quiet, keep them in vehicles, or leave the grounds. Limiting early morning stakeout of dogs will help to eliminate barking.

If we have noise complaints, then our club will not be allowed to enter the grounds until 8:00 a.m., and no over night stays of either dogs or people will be permitted.

The Ottawa Eagle Field Trial Association and Dept of Natural Resources realize that this is and has been a field trial ground for many years, and does not expect that dogs will never bark. But as good neighbors it is important that early morning barking is controlled.

Do not leave dogs unattended in rooms and keep leashed when outside rooms. Be responsible in cleaning up after your dogs on motel grounds and elsewhere.
