Directions:

From interstate 10 east of Tucson exit at Hwy 83 south to Sonoita approximately 17 miles. At Sonoita turn left, east on Hwy 82, approximately 3.8 miles to the south entrance of the Empire.Cienega Resource Area. Turn left, north, on narrow gravel road and proceed to trial grounds, approximately 3 miles which is the Road Canyon site.

Near by hotels: The Sonoita Inn (520-455-5935) limited space. The Stage Stop Inn in Patagonia (520-394-2211) approximately 25 minutes from grounds. Hotels on the east side of Tucson are 45 minutes from trial grounds, Sierra Vista hotels are 35 minutes.
