The winner of the OAA stake becomes the winner of the Ruby Trimble Award and will have the name of the dog, the owner, and the handler inscribed on a plaque.  
This award dates from 1985.

## Directions To Field Trial Grounds:

**From the North – You must get on State Highway 5 at Lebanon.**

**From Lebanon** – Take Mo Hwy 5 South from Lebanon to Meadowlark Road. There is a large wooden silhouette of a Pointer on Mo-5 on the right. Turn Right onto Meadowlark. Go west and angle right at the “Y” in the road. Stay on this road until it swings south. The Sportsmen’s Assoc. Clubhouse and barns, etc. are a short distance south, past the creek crossing, on the Right. If you drive all the way into Grovespring on MO-5 before turning on Meadowlark, you have gone too far. However, see below:

**From Grovespring** : Go to Mo Rte M and turn West. Go to Parks Creek Road (look for wooden silhouette of a Pointer on the right – not far past MFA Feed Store); turn Right and follow gravel road to the Clubhouse. There is one “Y” in the road – go to the right. Go past Andy Daugherty’s house and kennel and continue down the valley to the clubhouse and stables (on the left). **This may be the best route if roads are slick because it is the flattest. It is not the straightest.**

**From the South** – From I-44 - Take Conway Exit, go to MO-5, turn R (south) and follow above directions. (There is no easy way from the South.)
