**Directions to Field Trial Grounds:****From the North-** You must get on State Highway 5 at Lebanon.

**From Lebanon-** Go South on Mo Hwy 5 to Meadowlark Road. There is a large wooden silhouette of a Pointer on Mo-5 on the right. Turn Right onto Meadowlark. Follow it west until it swings south. The Sportsmen's Clubhouse and barns, etc. are a short distance south on the Right. If you drive all the way into Grovespring on MO-5; you have gone too far.

**From Grovespring-** Go to Mo Rt M and turn West. Go to Parks Creek Road (look for wooden silhouette of a Pointer on the right – not far past MFA Feed Store); turn Right and follow gravel road to the Clubhouse. There is one “Y” in the road – go to the right. Go past Andy Daugherty's house and kennel and continue down the valley to the clubhouse and stables (on the left).

**From the South-** From I-44 - Take Conway Exit, go to MO-5, turn right (south) and follow above directions. (There is no easy way from the South).

**COURSES & BIRDS**

**All Stakes**

**OAA and OGD:** 3-hour continuous course without a bird field on Native & Pre-Released Bob White Quail.

**AGD, OD, AAA, OP:** Continuous course (without horse killer hill) without a bird field on Native & Pre-Released Bob White Quail.

**No shot will be fired in puppy stake**

**PRIZES**

Standard AKC Rosettes to all placed dogs.  
Trophies to winner in each stake.

**PURSE (OAA & OGD)**

65% of entry fees for dogs run (*after stake expenses*)  
will be returned to handlers, split  
1<sup>st</sup> – 40%, 2<sup>nd</sup> – 30%, 3<sup>rd</sup> – 20%, 4<sup>th</sup> – 10%

**ALL STAKES**

**Horseback handling** will be permitted in all stakes. Horses will not be provided by the club.

**Firearms:** Only manufactured solid barrel firearms, with blank shells or crimps, which prevent a projectile of any kind from leaving the barrel are permitted.

**Tracking Collars:** Permitted in accordance with AKC guidelines.
