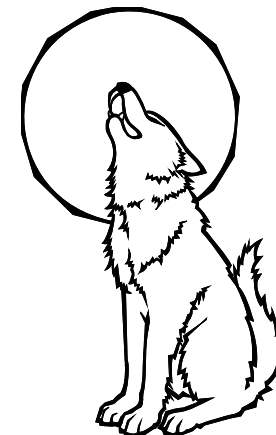

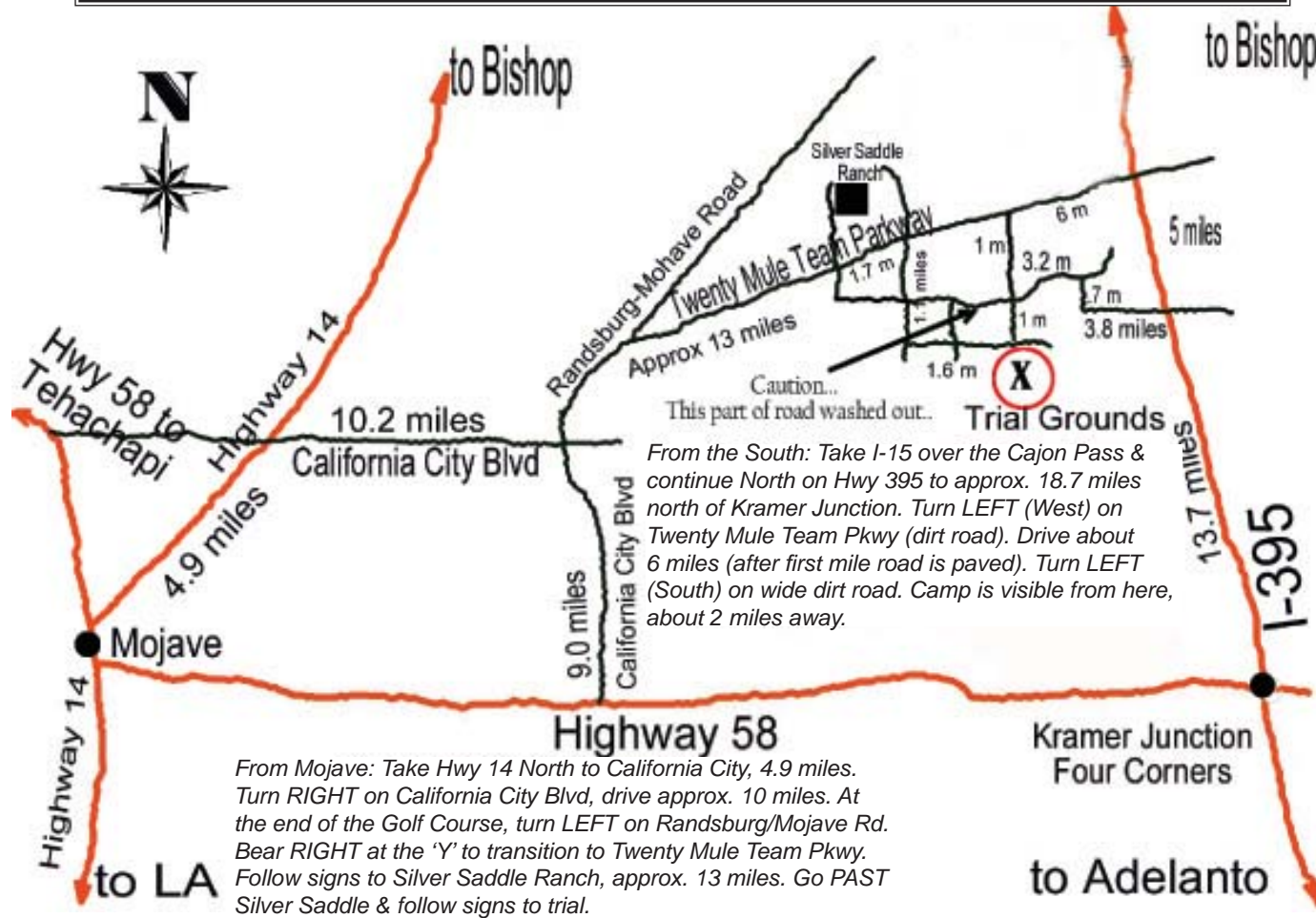

# HIGH DESERT BRITTANY CLUB

CASTLE BUTTE WELLS FIELD TRIAL AREA

Lodging Available in Mojave - The Mariah Country Inn, 661-824-4980



Look for Hwy 395 as soon as you go over the Cajon Pass. Stay in the RIGHT lane of I-15 so you don't miss Hwy 395. It's before you get to Main St. in Hesperia. From I-15, it's about 42 miles on Hwy 395 to Kramer Junction.

If the traffic on I-15 over the Cajon Pass is moving along, it takes about two hours to get to the grounds from the intersection of I-210 and I-15. (From Mojave, it's about 45 minutes.)

After you turn off Hwy 395, you will be on a VERY rough dirt road, but only for a mile. The rest is asphalt, but watch for the potholes.
