## Directions to the Grounds (see map on last page)

Go East on Berdan/340<sup>th</sup> Street (at Grade School) to Plymouth Avenue (which is the first gravel road); go North ½ mile on the gravel road and it is on the right side. Signs will be posted at the corners indicating where turns are to be made from Eddyville.
