All horses on the grounds need current coggins and health certificates. No horses will be available for rent.

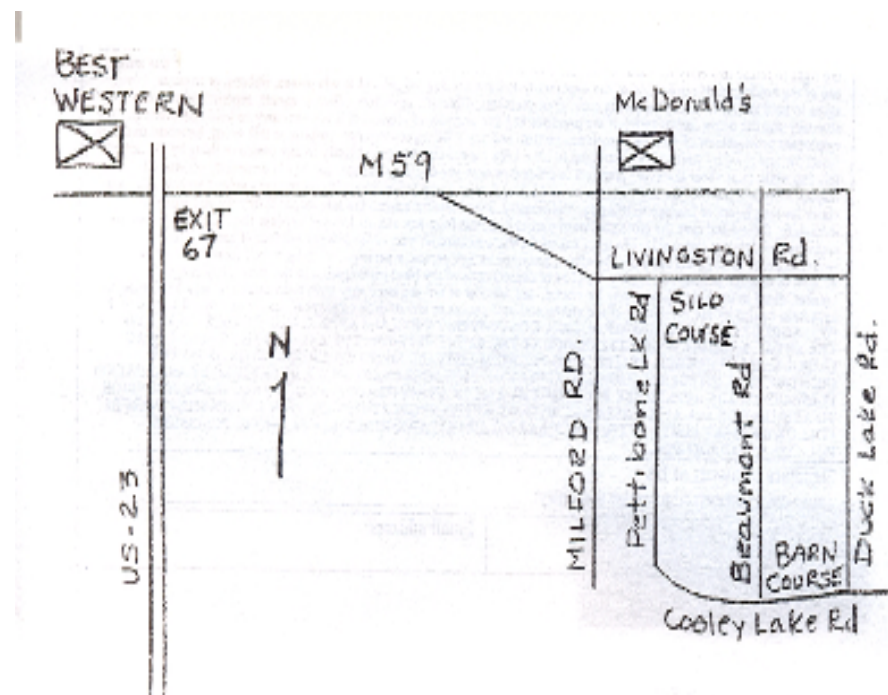
Dogs need a current rabies vaccination certificate.
