The road will eventually turn into a dirt road; you will cross two cattle guards and then make a sharp right turn remaining on the dirt road. Keep following this road until you see our camp (on the left). If you have reached the river, you have gone too far.

- Dogs and owners of any age may compete (registered or un-registered)

Entrants will walk a 20 minute course with a bird field where each dog will have the opportunity to work at least one bird. Judges will guide and advise handlers and provide feedback/answer questions following each brace. Firing a blank pistol with each bird contact is encouraged but not required. Loaner field trial equipment (blank pistol, colored dog collar, tracking collar, etc..) will be available.

Prizes: Awards will be given for varying aspects of performance

Note: This is a nonconforming event and is designed to provide the experience of entering a field trial. The event does not provide championship points and is not subject to the rules of the standard conforming field trial stakes.
