From Memphis:

Take I40 East towards Nashville
Take Exit 18 onto US64 East toward Bolivar Somerville go 2.4 mile
Turn Right on Houston Levee Road go 3.5 mile
Turn L on Macon Road (Tn 193) go 5.2 mi
Continue on Tn 193 go 0.8 mile
Arrive at 905 Highway 193, Collierville on the Left.

From Nashville:

Take I40 West (approx 182 Miles)
Take Ramp toward New Airline Road
Turn Left on New Airline Road, go 1.5 miles
Continue on Collierville-Arlington Road 6.5 miles
Turn Left on Macon Road (Tn 193) go 0.8 miles
Arrive at 905 Highway 193, Collierville on the Left.

From Jackson, Ms.

Take I55 North approximately 198 miles
Exit 2A/Tn 175E onto E. Shelby Drive 14 miles
Turn L on Forest Hill Irene Road go 0.4 miles
Bear right on Tn 385 East and go 3.7 miles
Take Byhalia Road Exit and go 0.4 mile
Turn right on Poplar Ave go 1.9 miles
Turn Left on Collierville Arlington Road go 8.2 miles
