Vests

It is mandatory that a blaze orange vest or jacket be worn as an outer garment.

Guns and Ammunition

Handlers in all levels need a blank pistol, incapable of shooting live ammo. Handlers in the Master Level need to carry an empty shotgun. The official Guns may carry only double barrel shotguns of at least 20 gauge. Semi automatics and pump guns are prohibited.

Electronic Devices

Electronic devices, including beeper or locator collars and dummy devices, as well as prong, pincher or shock type collars shall not be worn by a dog while it is running in a hunting test.

Conduct on the grounds

During the running of a hunt test, there shall be no training on the grounds. During the running of a hunt test, there shall be no firing of live ammo, except by the Official Gunners during the test. During the running of the hunt test, there shall be no firing of blank pistols, except by the handlers during their brace running time.

Humane Treatment of Game

AKC rules and regulations clearly prohibit any hobbling or shackling of game. **No One** has the authority to order game crippled or maimed. Anyone guilty of violating AKC rules and regulations will be severely disciplined.
