Directions: From I-5..take Exit 88(Tenino/A berdeen). Turn West towards Rochester..(Right if coming from the North and Left if from the South) Follow Hwy 12 about 13 miles to the city of Oakville. In Oakville..turn left on State St. which becomes S. Banks Road..Follow it to 2009 S banks Road..You will see a large Dept of Fish & Wildlife sign and should see cars and motorhomes..
On the day of the event....be sure to check in at the Headquarter table...

1. Remember to bring plenty of water for you and your dog(s).
Also be prepared for any kind of weather....You never know what to expect in June.
2. Lunch will be available both days for a \$5.00 donation...children \$3.00...
3. Overnight camping is permitted..
