- 1. Please type or print all information.
2. Consent in writing must be obtained from your parent club and be in the office of the AKC before this application can be considered.
3. For final approval, the following must be completed and returned to AKC Event Operations at least three (3) months prior to the start of the trial:
- Application and Judges Panel
- Required Fee
- Disaster and Emergency Plan (a separate form for each event is required)
- Current membership and officer list
- Current By-Laws must be attached if this is the club's first licensed trial, or if revisions have been made since the last set was filed with AKC.

Return all of the above information together.

- 4. A license fee of \$25.00 is to be submitted with each application. No fee is required of a Member Club for the first event within a calendar year, but a \$15.00 fee must accompany an application for an additional event to be held within that year.
A monetary fine (\$50.00) will be imposed for an application and/or judges panel not received at least three (3) months prior to the scheduled start of the trial. An event will not be approved until the fine is received.
5. When approved by the AKC, the information given on this form must be printed in the premium list along with any other information required under the respective Field Trial Rules. As stated in AKC's Rules and Regulations, premium lists may be printed only when the club has received notices that both the application and the judges' panel have been approved. Clubs must submit premium lists (field trials - 2 copies; hunting tests - 4 copies) at the time of distribution. Failure to do so may result in a fine, failure to receive approval for future events or both.
6. This event is held under the Rules and Procedures of the American Kennel Club. The information on this form, when approved by the AKC, shall be final and no changes may be made without AKC authorization.
